The preceding list is not inclusive and is meant solely to emphasize the level of risk and danger inherent in the sport of pickleball at any level of competition.

I recognize the risk inherent in the game and hereby release Fifty West Brewing, LLC DBA 50 West Burger Bar Pickleball League from any liability whatsoever arising out of or in connection with the Fifty West Brewing, LLC DBA 50 West Burger Bar- Pickleball League, including any liability due to the negligence of a breach of care of my contract of my participation involvement at Fifty West Brewing, LLC DBA 50 West Burger Bar. I further acknowledge that I have read the above release and understand that I am relinquishing any and all rights that I, or any of my dependents, or my heirs, executors or administrators might have against Fifty West Brewing LLC DBA 50 West Burger Bar for any loss, damage, injury or expense suffered by me in connection with all activities associated with my participation in the Pickleball League.

In consideration of being permitted to compete in Fifty West Brewing, LLC DBA 50 West Burger Bar – Pickleball League, I hereby release and forever discharge from any claim and liabilities whatsoever without limitation I might have against Fifty West Brewing, LLC DBA 50 West Burger Bar in the Pickleball League I am involved in, and make this release on behalf of my heirs, executors, administrators and assignors.

A Note on Dogs: Fifty West Brewing, LLC DBA 50 West Burger Bar requires the owner or individual in possession of a dog which is on the property of 50 West Burger Bar as an invitee/patron shall keep at all times the dog in the following manners:



1. Firmly secured by means of a collar and chain or other device (leash), so that it cannot stray beyond the premises on which it is secured.
 2. Under the reasonable control of some person preferably the owner at all times.
 3. Confined exclusively to the patio and taproom areas.
 4. Off of the boardwalk area, volleyball courts, ice rink, balcony, parking lot (unless returning to a car), and inside the brewing production center at all times.
 5. Management reserves the right to deny access to any dog or other animal at any time.
- **If any of the above terms regarding dogs are violated, the owner(s) and dog(s) will be required to leave the premises immediately.**
